3 概要

クレーマー PT-102VN は、コンポジットビデオ信号の分配器です。 1入力のビデオ信号に、正確なバッファリングとアイソレーションを行い、2系統の同一ビデオ信号を分配出力します。

PT-102VN の特長:

- ・ BNC コネクタの 1 入力のビデオ信号を、2 系統の同一ビデオ出力信号として分配します。
- ・ 430MHz の帯域を持ち、重要な用途において、透過性の維持を実現します。
- ・ ケーブルによる減衰を補正するために、ゲインとイコライズ (EQ)の調整機能を持ちます。
- · Pico TOOLS[™] サイズの PT-102AN 1:2 音声分配器と理想的に適合して動作します。




図 1: PT-102VN 1:2 コンポジットビデオ分配器

4 PT-102VN の接続

注意: PT-102VN に接続する前に、各機器の電源を OFF にしてください。
PT-102VN に接続した後に電源を接続して、各機器の電源を ON にしてください。

PT-102VN は次のように使用できます。

- ・ 1:2 コンポジットビデオ分配器として
- · 入力数を増やすため、4x1VB 4x1 広帯域ビデオスイッチャーと接続
- ・ 出力数を増やすため、105VB 5:1 広帯域コンポジットビデオ分配器と接続

4.1 PT-102VN 1:2 コンポジットビデオ分配器の接続

PT-102VN 1:2 コンポジットビデオ分配器の接続例を図 2 に示し、次のように接続します。

- 1. コンポジットビデオソース機器(コンポジットビデオプレーヤーなど)を入力 BNC コネクタ に接続します。
- 2. 2 つの出力 BNC コネクタに 2 台までのコンポジットビデオ入力機器を接続します。
 - 出力 1 BNC コネクタに、ビデオ入力機器 1 (プロジェクターなど) に接続します。
 - 出力2 BNC コネクタの、ビデオ入力機器2 (ディスプレイなど) に接続します。
- 3. 12V DC 電源アダプタを本機の DC 入力に接続して、アダプタを主電源に接続してください。
- 4. 必要に応じて、出力信号レベル調整、イコライザ調整をしてください。




図 2: PT-102VN 1:2 コンポジットビデオ分配器の接続
